Patron for the Awards

His Excellency, the Right Honourable David Johnston, C.C., C.M.M., C.O.M., C.D., the Governor General of Canada, is the Patron of the Awards.

The *Canada Awards for Excellence* (CAE) is an annual awards program to recognize business excellence in quality, customer service, and healthy workplace. Since 1984, the Awards have been presented to private and public sector organizations of all sizes that are world class. This prestigious award is tangible evidence of an organization's level of excellence.

This award is based on the Excellence Canada Framework for Organizational Excellence, which is used by numerous organizations as a management model for continuous improvement and the achievement of significant operational results.

Canada Order of Excellence (COE)

The Canada Order of Excellence is awarded to organizations that have previously received the CAE Gold trophy for one of the following:

- Excellence, Innovation and Wellness (formerly Quality and Healthy Workplace®)
- Quality (Private and Public Sectors)
- Healthy Workplace®
- Education Organizations apply every three years to remain in the Canada Order of Excellence category.

The COE is the highest level of achievement that an organization can receive in Canada. His Excellency, the Right Honourable David Johnston, C.C., C.M.M., C.O.M., C.D., the Governor General of Canada, has bestowed his Patronage on the Canada Awards for Excellence program.

Adjudication Process

Excellence Canada follows a thorough adjudication process for the Canada Awards for Excellence. Each year, it is our objective to select the very best organizations in every category so that we can reward those that best meet the Criteria and are most committed to the cause of improving Canada's performance on the world stage. To ensure total accuracy and the most qualified recipients of these prestigious awards, we conduct a site verification visit.

Please note that organizations do not compete against one another, but rather are judged against the individual Criteria.

Site Verification

Organizations that pass an initial screening are visited by teams of examiners to verify information on the application. A Lead Verifier will be identified to head up the site visit.

The purpose of the site verification is to verify major aspects of the submission on-site, clarify any points still outstanding and for the verifiers to meet with people at different levels in the organization. You may be asked to set up focus groups to meet with the Lead verifier and his/her team. You may also be asked to provide additional documentation.
